Davey Day Care

Our focus, every day is the children and families we serve. The cost of living continues to be a challenge and we appreciate that childcare costs can be a source of worry. There is government support available; let us help you understand what the options are and how to get it.

Here's our guide to funded hours we hope you find it helpful.

What's Available?

- Standard Universal Funded Childcare 11 stretched hours or 15 term-time hours. Available to all 3 and 4-year-old children, the term after they are 3.
- 2-year-old Funded Childcare 11 stretched hours or 15 termtime hours, the term after a child turns 2 years old (Eligibility dependent)
- Eligibility Funded Childcare 22 stretched hours or 30 term-time hours (Eligibility Dependent) the term after your child is 9 months old you may be eligible for this funding funding is made up of two parts: 11 stretched hours or 15 term-time universal plus an additional 11 stretched hours or 15 term-time hours extended dependent on individual family circumstances.

Funded Hours—what you need to know

Universal Funded Childcare for 3 and 4 year olds

All parents of children aged 3 and 4 are entitled to government-funded childcare starting from the term after their child's third birthday, continuing until they begin school.

You can choose one of the following options:

Term-Time Only (38 Weeks per Year)

Total funded hours per year: 570 hours

Maximum hours per week: 15 hours Available during school term time only.

All-Year Round (51 Weeks per Year)

Total funded hours per year: 561 hours Maximum hours per week: 11 hours Spread evenly across 51 weeks of the year.

How to Apply?

Simply contact us to let us know you'd like to use your funded hours at our nursery, and we will guide you through the process.

Funded Childcare 11 & 15 hours the term after 2 years

Some parents may be eligible for **11 or 15 hours of funded childcare** for their 2-year-old, starting from the term after their child's 2nd birthday.

You may qualify if you:

- Receive certain benefits, such as Income Support or Universal Credit, or
- Your child receives Disability Living Allowance (DLA), or
- Your child has an Education, Health and Care (EHC) Plan

How do I get it?

You will need to **apply through your local council** to access this funding. For more information and to apply, visit: <u>Funded early education for over 9 months</u> up to 2 year olds | West Northamptonshire Council

Funded Childcare 22 or 30 hours

You may be eligible for an additional 11 or 15 hours of funded childcare, on top of the universal entitlement. This gives a total of 22 or 30 hours of funded childcare per week, starting from the term after your child turns 9 months old, provided you meet the government's eligibility criteria set by the government.

What do I need to do?

Funding is based on your **family's eligibility**, and you must **apply and obtain a valid funding code** within the correct time frame.

To qualify, you must:

- Be working and earning at least the equivalent of 16 hours a week at the national minimum or living wage, and
- Earn less than £100,000 per year (per parent). For couples, both partners must meet this criteria. If one parent is not working or earns over £100,000, you will not be eligible.

Note: You may also **not qualify** if you are claiming Universal Credit.

How to Apply

Visit to <u>www.BestStartinLife.gov.uk</u> check eligibility and submit your application.

The application takes around **20 minutes**, and you'll need:

- Your National Insurance number, or
- A Unique Taxpayer Reference (UTR) if self-employed.
- Couples must provide details for **both partners**.

If your application is successful, you will receive a **funding code**. **Send the code to us** to secure your child's place at **Davey Day Care**.



Funded hours at Davey Day Care's

At **Davey Day Care**, we believe in being **open and transparent** about how government-funded childcare works and what is included.

Whilst the funding covers the cost of the childcare place, we believe that there is only one start in life and one chance to maximise your child's opportunities and experiences during their formative years.

Prior to children entering school, 95% of their brain has already developed! At Davey Day Care, "Quality Childcare" is the core of our philosophy for early years education.

We offer two service options. "Basic package" where you would opt **OUT** of paying a consumable charge and "Exclusive package" where you would opt **IN** to paying a consumable charge.

'Basic Package' - Fully Covered by Government Funding "Opt Out"

The **Basic Package** includes everything that the government funding is intended to cover, including **core childcare provision**. This ensures there are **no additional costs** for funded hours.

What's included:

- Core care and learning resources, such as Stationery, paints, toiletries, and essential consumables, Toys and resources such as small world figures, role play materials, puzzles, books, and craft supplies, Sand and water play experiences, Loose parts and construction toys.
- ✓ Staffing costs salaries for delivering the EYFS curriculum, meeting minimum government ratios.
- Essential running costs, including rent, utilities, business rates, repairs, and maintenance
 This list is including but not limited to the above

This package delivers high-quality care at a level that meets all government requirements for funded childcare.

Please note:

Government funding covers the cost of the childcare place but it does not cover the cost of food, consumables and enrichment activities.

This package includes **everything from our Basic Package**, plus a wide range of extras to ensure your child enjoys the **highest quality care**, enriched **educational opportunities**, and a setting that supports their **learning and development**, while giving you **convenience and peace of mind**.

Nursery funding - It's Your Choice

At Davey Day Care, we have always covered the cost of our enhanced provision through a charge called the "Non-Funded EYFS Hour." This meant we could only offer up to 9 hours of funded care per day.

We are now moving to a new consumables charge system, giving parents the choice to opt in for our **Exclusive Package** or opt out for our **Basic Package**.

This change will also allow us to extend the funded care we can offer, to 10 hours per day.

Our goal is to continue providing funded places, but this is only sustainable if parents understand why we charge a daily funded session consumable fee and choose to continue paying it — as they have been since we opened.

We know our parents choose Davey Day Care because they want their children to benefit from the full experience we offer.

By introducing a daily funded session consumable fee for those accessing our **Exclusive** provision, we can continue to deliver the exceptional care and learning opportunities that we are proud to be known for.

The Government Statutory Guidance states that:

"The funding is intended to cover the cost of delivering the childcare place itself, including:

- Staff wages
- Premises
- Basic learning resources
- Activities required to meet the Early Years Foundation Stage (EYFS) framework

What the Funding Does Not Cover

The guidance explicitly states that the funding does not cover the cost of consumables."

Opt-Out - "Basic Package"

Parents who choose to **opt-out** will receive:

- Everything included in our Basic Package
- Access to the EYFS provision as funded by the government
- Their funded hours completely free of charge

Important Information About Opting Out

By opting out, parents agree to take full responsibility for providing certain items and services, as outlined below:

♦ Meals & Snacks:

Parents must supply all meals and snacks for their child, following our **Food Policy**.

If food provided does not meet our policy requirements, we will ask you to return with a suitable alternative before your child can eat.

♦ Consumables:

Parents must provide essential consumable items, including **nappies**, **wipes**, **and sun cream**.

If these items run out and we have notified you, you will be required to return promptly with the necessary supplies.

♦ Limited Enrichment Experiences:

Some enhanced activities may **not be included**, though we will always ensure a **high standard of care**.

- ♦ No Soft Play Access
- No Nursery Visitor Experiences, such as visits from: Firefighters, police officers, soldiers, dentists, and other community professionals.

Excludes everything listed in the Exclusive package.

Opt-in – "Exclusive Package"

Parents who opt-in will continue to receive: Everything listed in our "Exclusive Package"

As per the government legislation, children can receive 15 hours funding over a 38 week period, the term after they turn 3 (15hrs x 38 weeks = 570 hours per year) This is called **Universal hours**



Parents can apply for **Extended Funding** starting from the **term after their child turns 9 months old**.

This funding combines the **Universal entitlement** with an additional **15 hours of Extended Funding**, giving a total of **30 hours per week** over a **38-week period** (term-time).

How it works:

- Universal Funding: 15 hours × 38 weeks = 570 hours per year
- Extended Funding: 15 hours × 38 weeks = 570 hours per year
- Total Funding: 570 + 570 = 1,140 hours per year

Please note: Extended Funding is subject to eligibility criteria set by the government.

If deadlines are not met, parents will not be able to claim funding for that term.

Your Questions Answered!

Do We Offer Totally Free Places?

Yes, we do — although we prefer to describe these as 'funded' places rather than 'free'. Parents can access their funded hours with no additional charges if they choose to. This is called our "Basic Package"

However, many families opt for our **Exclusive Package** because it offers excellent value and added convenience.

This package includes everything listed in our Exclusive Package description, ensuring that children benefit from a consistent, high-quality experience, while making things simpler and more manageable for busy parents.

Nurseries in My Area Allow Packed Lunches – Do I Have to Provide Lunch?

At Davey Day Care (DDC), families can choose between our Exclusive Package and Basic Package.

- If you opt for the Exclusive Package, all meals and snacks are provided by us.
- If you opt for the Basic Package, you will be required to bring a packed lunch to cover snack, lunch and tea for your child, following our strict Food Policy (see page ____ for full details).

To ensure the health and safety of all children, any lunch that does not meet our Food Policy requirements must be replaced.

If this happens, you will be asked to return with an alternative meal before lunchtime.

If I Pay for Extra Hours and Don't Use Them, Can I Be Refunded?

Unfortunately, we are unable to offer refunds for unused hours.

This is because we must cover our running costs and staffing to ensure we can continue providing high-quality care for every child at DDC.

Can I Roll Over My Funded Hours Into the Next Term?

Unfortunately, we are unable to roll over funded hours due to local authority regulations.
However, we can stretch your child's funding within the current term to make the most of their

entitlement.

When Will My Child Receive Their Funding, and Will My Invoice/Fees Go Down?

At Davey Day Care (DDC), we calculate your child's fees in advance, taking into account any funding they are entitled to for the funding year, which runs from April to March.

The total funding is applied and included within your overall fee calculation.

We then divide this amount equally across the year, so your monthly invoice stays the same.

This means there won't be changes to your invoice when funding starts, as it has already been incorporated into your fees from the beginning.

Changes to Your Circumstances

If your personal circumstances change and you are no longer eligible for funding, we will:

- Provide you with a settlement figure, and
- Recalculate your fees based on your updated funding status.

This ensures that your account remains accurate and up to date.

Do I Have to Pay for Bank Holidays If They Fall on a Day My Child Attends? Can Funding Be Applied to Bank Holidays, or Are They Charged at Full Price?

Yes, bank holidays are fully chargeable, even if they fall on a day your child normally attends.

In line with government legislation, funding cannot be applied to bank holidays, and full fees will apply.

Why Am I Still Paying Fees in August When My Child Attends Term-Time Only?

For term-time only children, fees are calculated based on 38 weeks per year.

To make payments easier and more manageable, we spread the total cost evenly across 12 months (April to March).

This means your monthly invoice remains the same, even during school holidays, such as August, when your child may not be attending.

Can I Use Funding for Additional Ad-Hoc Days or Hours?

No, funding can only be applied to your child's regular booked sessions.

Any extra ad-hoc days or hours will be charged at our standard rate and cannot be covered by funding.

Why Are Bank Holidays Chargeable?

Bank holidays are fully chargeable because our running costs remain the same, even when the nursery is closed.

This includes essential expenses such as:

- Building and utility costs rent, electricity, and maintenance continue regardless of closure
- Resources and equipment ensuring everything is ready for children when they return

In addition, government funding cannot be applied to bank holidays under national regulations, meaning these days must be charged at full price.

By keeping these charges consistent, we can continue to provide high-quality care and education for all children throughout the year.

Does My Child Need a Water or Milk Bottle?

No, you do not need to send your child with a water or milk bottle. At Davey Day Care, we provide:

- Water bottles for all children throughout the day
 - Tommee Tippee and MAAM milk bottles for feeding

To promote healthy habits, we do not allow flavoured water, squash, or other sweetened drinks in the nursery.

I've Missed the Deadline to Apply for My Eligibility Code — Can My Child Still Be Funded?

Eligibility codes only provide funding from the term after you apply.

If you miss the deadline — which falls on the last day of **March**, **August**, and **December** — we won't be able to access the funded hours until the following term. If your child is aged 3 or above, you are still entitled to 15 universal funded hours, regardless of whether parents are

working.
To remain eligible for 30 hours of funding, HMRC will prompt you to reconfirm your code before the start of a new term. It's important to do this on time to avoid delays in accessing your funding.

We will then check it with the local authority and confirm your child's funded place.

I'm Planning to Take My Child on Holiday — How Will This Affect Funded Childcare?

If your child will be away for up to two weeks, this is usually fine, but we kindly ask that you give as much notice as possible so we can plan accordingly.

If your holiday will be longer than two weeks, please speak to the Manager at

How Much Notice Do You Require to Change My Child's Hours at Nursery?

As stated in our Terms and Conditions, we require 4 weeks' notice for any changes to your child's agreed booking plan. If your child receives funding and you give notice midway through a month, the change cannot take effect immediately. Instead, it will be applied from the start of the following whole month, after the 4week notice period has ended. This process ensures that funding allocations remain accurate and that we can plan our staffing and resources effectively.

Can I Use My Funding Across Two **Settings?**

Yes, you can split your child's funded hours between two different settings, as allowed under current government auidelines.

However, there are a few important points to be aware of:

- Both Setting must provide the same type of funding either stretched or term time only
- Communication Between Settings: You must inform both settings about how you plan to split the funding, so we can correctly record and claim the appropriate number of hours for your child.

Can I Change Between the Basic and Exclusive Packages, and How **Much Notice Is Required?**

Yes, you can switch between the Basic Package and the Exclusive Package at any time.

> We require 4 weeks' notice for any changes to ensure we can plan staffing, resources, and funding allocations effectively.

Do I Need to Label My Child's Clothes and Shoes?

Yes, please ensure that all clothes and shoes are clearly labelled with your child's name.

Your child's bag can remain at nursery. We will send it home if:

- Any spare clothes from the bag are used, or
- The season changes and more appropriate clothing is needed.

This helps us keep your child's belongings safe and organised.

What Is the National Guidance on Staff-to-**Child Ratios?**

At Davey Day Care, we follow the national guidelines for staffing ratios to ensure children are safe, well-supported, and receive high-quality care.

The required ratios are:

- Under 2 years old: 1 adult to 3 children
- Ages 2 to 3 years: 1 adult to 5 children
- Ages 3 years and above: 1 adult to 8 children

These ratios are set by the government to ensure that every child receives appropriate attention, care, and supervision at all times.

Can My Child Bring Toys to the Setting?

No, children should not bring personal toys to nursery. Toys can:

- Get broken or lost
- Cause a choking hazard to other children
- Upset children if items go missing or are damaged

Exceptions:

- If your child needs a comforter, blanket, or soft item, please:
 - o Label it clearly with their name
 - o Inform a member of staff that it is in their baa
- If toys are brought in specifically for a project, please:
 - Label them clearly
 - Keep them in a separate baa

This ensures children's belongings are safe and organised, and all children can enjoy a secure environment.









Davey Day Care - Food Policy for "Basic Package" Families who Opt-Out

At Davey Day Care (DDC), we have a strict Food Policy in place to protect all children and ensure a safe, healthy environment. This policy is especially important as:

- We care for children with a variety of allergies, and
- Food is used as part of our educational programs to encourage healthy habits and learning experiences.

Families who have opted for the Basic Package must adhere to this policy at all times.

What You Must Provide

Depending on the sessions your child attends, you are responsible for supplying the following meals:

Full-Day Sessions 8 to 6: Half-Day Morning Half-Day Afternoon Morning snack Sessions 8 to 1: Sessions 1 to 6: Lunch Morning snack Afternoon tea Lunch

Please ensure these meals are packed safely and meet our healthy food guidelines below.

Food NOT allowed:

Crisps

Chocolate

Sweets or confectionery
Squash or flavoured water

Drinks Provided by DDC

Milk and water are provided by DDC throughout the day.

If you do send a drink, it must be plain water only, no squash, juice, or flavoured water

Food Hygiene Requirements

To meet food hygiene requirements, each lunchbox must include an ice pack to keep food at a safe temperature throughout the day. Food will **NOT** be refrigerated. Please ensure your child's lunchbox is clearly labelled.

If a lunchbox is sent without an ice pack or label, we will contact you and ask that you return with the necessary items before mealtime.

Healthy Food Guidelines

We encourage balanced, wholesome meals to support your child's growth and learning. Here are some suggested foods you can include:

Carbohydrates (for energy):

- Wholegrain wraps, pita bread, or sandwiches with healthy fillings
- Pasta or couscous salads
- Brown rice or quinoa
- Wholemeal crackers or breadsticks
- Rice cakes or oatcakes

Fruits & Vegetables (vitamins and fibre):

- Carrot, cucumber, or pepper sticks
- Cherry tomatoes (halved or quartered)
- Steamed broccoli or green beans
- Apple slices (with skin removed if preferred)
- Banana chunks
- Berries (e.g., blueberries, strawberries cut if needed)
- Grapes (cut lengthways to prevent choking)
- Dried fruit like raisins or apricots (in moderation)

Proteins (for growth and development):

- Sliced boiled eggs
- Cooked chicken or turkey slices
- Cheese cubes or cheese sticks
- Natural yogurt or fromage frais
- Hummus or bean dips
- Tuna or salmon (boneless and well-cooked)

Healthy Extras:

- Plain popcorn (no added salt, sugar, or butter)
- Wholegrain breakfast bars (low sugar only)

Important Note

If a meal does not meet our Food Policy requirements, we will contact you and request that you provide a suitable alternative before mealtime. This policy helps us:

- Keep all children safe, especially those with allergies.
- Promote healthy eating habits.
- Support our educational activities involving food.
